CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely Christian College of Education, Venkatesapuram, Perambalur Post & Perambalur Taluk, Perambalur District-621212, Tamilnadu vide SRC (NCTE) order no.F./SRO/NCTE/2007-2008/16026 dated 17.12.2007 for conducting Secondary B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 24.01.2015 & for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. courses of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st, Nov, 2019 considered the matter and decided to issue SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a Show Cause Notice was issued to the institution on 29.12.2020. The institution has submitted the reply vide dated 21.01.2021 in response to the Show Cause notice.
- 4. AND WHEREAS, the SRC in its 395th meeting held on 25th 26th February, 2021 considered the matter and decided to issue Final Show Notice to the institution. Accordingly, as per decision the Final Show Cause Notice was issued to the institution on dated 08.03.2021. The institution vide letter dated 24.03.2021 submitted its reply to the Final Show Cause Notice.
- 5. AND WHEREAS, the matter was placed before the SRC in its 399th meeting held on 15th 16th June 2021 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Christian College of Education, Survey No. 452/7, 11th ward Perambalur Town Panchayat Perambalur P.O. Perambalur Taluk, Perambalur District-621212, Tamilnadu for B.Ed. programme for 2 basic units of 50 students each.

- 5. NOW THEREFORE, this order is issued permitting the institution i.e. Christian College of Education, Survey No. 452/7, 11th ward Perambalur Town Panchayat Perambalur P.O. Perambalur Taluk, Perambalur District-621212, Tamilnadu for Continuation of recognition for B.Ed. programme for 2 basic units of 50 students each subject to fulfilment of the following conditions:
- The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in

the NCTE Regulations, 2014 as amended from time to time.
